### Constable Report:

- A camera was placed to monitor the tire dumpster. No one has added to it.

### Recreation Committee Report:

- The Kickball Tournament was very successful.
- The Pickleball court (in the ice rink area) has been painted.
- The picnic tables have been repaired and stained.
- A Farmer's Market is being considered for July 20 at the ice rink.
- Trustee McGahan raked the infield and it's looking great. A half-tote of chloride was applied to the infield to keep it looking nice and keep weeds down.
- There is a stand-up basketball hoop that needs to be repaired. The Township has two backboards that can be used for this.
- J. Ploskonka will gather more information regarding the sign for the ballfield and will bring it to the Board for review. The anticipated cost is between \$600-\$700.
