Regular Meeting Wednesday, April 9, 2025

<u>Houghton County Jail Presentation</u>: Dr. Faith Morrison from The Copper Country League of Women Voters, County Commissioner Roy Britz and Sheriff Josh Saaranen gave a presentation and answered questions on the new jail project for Houghton County.

Old Business:

Bids are still coming in for the ice rink repairs for the Copper Shores Grant. Supervisor Spencer is meeting

submission.
